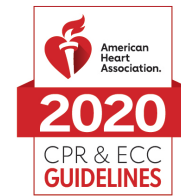

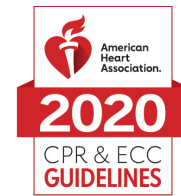

**TOPIC: COVID-19**

**Q. Do the 2020 Guidelines contain COVID-19 guidance?**



**A:** As the evidence and guidance are evolving with the pandemic, COVID-19-related information is maintained separately from the guidelines. In April, the AHA published a scientific statement that provides interim CPR guidance to help rescuers safely and effectively treat cardiac arrest patients with suspected or confirmed COVID-19 for both in-hospital and out-of-hospital settings.
